What I will learn?

- At the end of this program, students should be competent in the following areas:
- Explain the various functions of a management accounting system, and its relationship to both cost accounting and financial accounting.
- Understand and apply cost terms and concepts. Distinguish between the effect and implications of cost behaviour analysis.
- Develop functional analysis of cost-volume-profit and break-even concepts, and their implications.
- Distinguish between job order costing, and process costing systems.
- Describe and appraise the methodologies of cost accumulation for stock valuation and profit measurements.
- Understand the advantages and disadvantages of absorption and variable costing, in the context of decision-making, planning, and control.
- Understand the various types of variances and their impact on standard costing.
- Understanding, and preparation of budgets; Master, Production, Cash, and Flexible.
